CASE SUMMARY:

██████████ called to report both of her children ██████████ had been molested by Kevin G. Sloniker ██████████ said this happened at her nephews residence located at ██████████ When asked, Barbara said ██████████ and ██████████ had talked about this occurring approximately 9 times in the past.

NARRATIVE:

On 09-12-2015 I contacted Barbara by phone in regards to a L&L incident that occurred approximately 9 times at her nephews address.

Barbara said she is the mother of ██████████ and ██████████ Her nephew, Gabriel and his friend Kevin, had started to hang out with ██████████ and ██████████ at Gabriel's residence. She felt this was odd (Gabriel and Kevin wanting to spend so much time with the boys) however she let them "hang out" together because Kevin had helped Barbara "buy the boys clothes" and had assisted her with bills in the past when she was unable to afford them. Over time, ██████████ and ██████████ began to act strange when they would come back from Gabriel's residence.

On 09-11-2015, Gabriel and Kevin asked to take ██████████ and ██████████ to a movie. Barbara said she talked to her ██████████ and ██████████ and asked them if there was any good reason she shouldn't allow them to spend more time with Gabriel and Kevin. She didn't specify which child answered first however both of the boys told her about repeated sexual contact at Gabriel's residence.

When asked, they told her on 09-10-15 Gabriel was in the living room playing with his phone and playing games with them. Kevin took one boy at a time into the back bedroom and "forced" them to get undressed. Kevin would take his clothes off begin touching their genitals and had them touch his genitals. ██████████ and ██████████ told ██████████ Kevin would massage their groin area and their penls. They estimated this has occurred on 9 different occasions at this residence however at the time I talked to her, Barbara was unsure of the exact dates or time this started.

After telling ██████████ this, she attempted to call CPS however they were closed. She talked to a person at her church then called CDAPU. ██████████ said

and were "OK", safe with her and not allowed to go anywhere until this got resolved. She also told me they were not physically injured and did not need medical attention.

I advised Sgt. Odell of my interview and he contacted Detectives. Det. S. Harris and Det. C. Suhl responded to the PD and took over the investigation. See their report for further information.

On 09/12/15 I was contacted by the CDAPD investigations division in reference to a possible forensic interview.

I met Detective Harris and the two possible victims at the Children's advocacy Center (CAC) at approximately 1420 hrs. I interviewed _____ alone which was video and audio, digitally recorded. I used the National Institute for Child Health and Human Development (NICHD) model as a guideline for my interview with

Investigations Summary:

I observed the victim interviews and assisted Detective C. Buhl interview one of the two offenders. We spoke to Gabriel and during the interview admitted to his involvement in the sex abuse. We were unable to locate the other offender, Kevin because he left town as a long haul truck driver. (Transport Design Industries) I faxed a preservation of evidence form to Verizon Wireless. I briefed the on-call prosecutor Dave Robins of the progress in the case. Detectives will be obtaining an arrest warrant.

At approximately 12:00 noon I was contacted by the Patrol Sgt. D. O'Dell and requested to assist with a sexual abuse case. Sgt. O'Dell gave me a synopsis of the case. The allegations were two boys ages [redacted] and [redacted] were asked to undress and in the room of an adult male where there may have been some lewd conduct. I responded to the Police Department at 12:35 where I contacted Officer J. Bangs, Detective C. Buhl and Sgt. C. Wood. I was introduced to the two victims by officer J. Bangs and asked to escort [redacted] and her two young boys to the [redacted]

Mother: [redacted]

I spoke to [redacted] and told her I would be in contact with her throughout the day. I was advised by Barbie that the suspect Kevin had provided a cell phone to [redacted]. I asked for the cell phone and Barbie said it was at her home. I told her I would contact her later and collect that as evidence.

I contacted Barbie again by phone and she indicated she gave the phone back to Kevin several months ago after the glass was broken. Barbie indicated she believed Gabriel may have been victimized in the past.

Offender #1 Kevin Sloniker

Detective C. Buhl and I responded to Kevin's residence to contact him. He was not at home. I was informed by Barbie he was a long haul truck driver and he parks his "rig" across the street from the Winco. I also asked about Kevin's roommate Gabriel. Barbie said Gabriel was her nephew. [REDACTED] said Gabriel works at the [REDACTED] on Appleway in Cd'A. Patrol responded to Winco to locate the truck and I responded to the Beat Western.

Offender # 2 Gabriel Mokervey

I arrived at the front desk and asked to speak to Gabriel. Apparently Detective C. Buhl had already called and were aware we were coming to speak to him. I was approached by the Assistant General Manager Russell Koyser. He provided a conference room to talk to Gabriel and sent a message for him to come to the front desk.

When Gab arrived we introduced ourselves and spoke to him in the conference room provided to us. The following interview was recorded on my body camera and uploaded to Viper. The following is a short synopsis of the conversation. For a full version see attached video. I read Gab his Miranda Rights and he signed the form and agreed to speak to me. (see attached)

Gab was nervous and said he did not know why we wanted to talk to him. He thought it was about a different allegation where Kevin had touched a male inappropriately. Detective C. Buhl said he was aware of the case but said it was a different incident. Detective C. Buhl said it was reported Kevin was reported to have been touching and private parts. Gab lied several times to us and I observed several signs of deception. Lack of emotion, a low monotone voice and changing his story constantly.

Gab started by denying any knowledge of the inappropriate touching. After a long drawn out interview Gab slowly began to admit to direct knowledge of the behavior going on behind closed doors with Kevin. Gab admitted to receiving photographs from Kevin of the boys genitalia. He also admitted to having taken some photos of the boys with no shirt. They were posing with no shirt on and their pants pulled down almost exposing the genitalia. He admitted to sending the photos to Kevin. Gab gave Detective C. Buhl permission to look at his cell phone. He provided the user name and password. User: [REDACTED] and Password: [REDACTED]. Buhl was able to see some of the photos with Gab assisting. Gab even recalled a time when he walked into his bedroom and Kevin was there with who was totally naked. Gab provided a sketch to Detective Buhl. Gab said he just turned around and left the room, again failing to do anything.

Gab adamantly denied having touched the boys but admitted to transporting the boys over to his apartment where Kevin would have them undress and do the same thing all over again. Gab indicated this happened 7 to 8 times. The only difference was what they did after. Gab said Kevin would take them to get some food, and clothing and sometimes go to a movie. When I asked Gab why he allowed Kevin to abuse the boys he replied, "I don't have an answer." Gab confirmed he and Kevin told the boys not to tell Barbie that Kevin was with them. Once again Gab failed to give a reason for not doing anything.

Gab said Kevin would pay him money, pay a car payment, refuse to pay rent or threaten him if he ever told anyone about the boys. I asked Gab where I could find Kevin. Gab said Kevin was a long haul truck driver and this morning he dropped Kevin off at his truck and said he was sure he was on the road again and not due back for about three weeks. I asked about the cell phone Kevin provided to [REDACTED]. Gab said he saw it sitting on the microwave at her house a few months

ago.

Gab was arrested for felony injury to a child, two counts. Officer T. Neal transported Gab to the jail. I responded back to the police department here I called the on-call prosecutor, Dave Robins and ran the case by him. I completed a preservation of evidence form and faxed it to Verizon. I uploaded my video to viper and confirmed officer J. Wilhelm uploaded the victim interviews. I completed my portion of the report and passed it on to other detectives. Sgt. B. McCormick said he would have someone pick up the investigation first thing in the morning and obtain an arrest warrant.

C.V. Buhl / 09-12-15

Summary:

Gabriel Mckervey was arrested for two counts of injury to a child. Gabriel admitted to facilitating the sexual abuse of his two cousins, and Gabriel is friends with the suspect Kevin Sloniker. Gabriel would go to his aunts house and pick up the two children. Gabriel would bring the children back to his and Kevin's house in return for money paid to him by Kevin. Gabriel would keep one child occupied playing games while the other child was in the bedroom with Kevin. Once Kevin would finish with the first child Kevin would come get the second child. Gabriel would keep that child occupied while Kevin had the second child in the bedroom. Gabriel also admitted to taking half nude photos of the two children and sending them to Kevin. Gabriel admitted that he knew Kevin was probably masturbating to the pictures he sent. Gabriel made no attempt to stop the sexual abuse nor did he report this anyone.

On 09-12-15 I was notified about a lewd conduct with a minor case patrol was working. I met Detective Harris, Sgt. Wood and Detective Wilhelm at the PG. We met with Officer Bangs who briefed us on what happened. Detective Wilhelm met with the two victims, and their mother Barbara Mckervey. Wilhelm conducted forensic interviews with the two victims. Once the interviews were completed Wilhelm advised there was enough probable cause to arrest the suspect, Kevin Sloniker. Please see his report on the interviews.

This case involves the two victims,

. Their mother is [REDACTED]. The two suspects are Kevin Sloniker and Gabriel Mckervey. Gabriel is the cousin of the two victims. Kevin is a friend of Gabriel's.

We were told Kevin has been having sexual contact with [REDACTED] and [REDACTED] by touching their penis's and having them touch his penis. Gabriel facilitated these acts as being a coconspirator by keeping one child occupied as the other child was in the bedroom with Kevin. Once Kevin was finished with the first child he would switch and have the second child come into his room while Gabriel stayed with the other child and played games.

Detective Harris and I went to Gabriel and Kevin's home located at 4310 Crown St. There was no answer at the door. We spoke to a neighbor who told us Gabriel worked at the Best Western. I called and confirmed Gabriel was at work. We went to the Best Western where we spoke to Gabriel in a Boardroom.

Interview: Recorded and loaded into Viper.

I started the conversation by telling Gabriel who we were and I asked if he had any idea why we were there talking to him. Gabriel told us it was probably because Kevin had been accused of doing some things with a child in the past. Gabriel started telling us about the incident which occurred in April 2015 (15C09479). I told Gabriel that was not the reason we were there. Gabriel started telling us about some other trouble of the same nature Kevin was in.

trouble for in another state, I asked if he knew Barbara, and Gabriel said yes, Gabriel told us he did not know anything that happened between Kevin, or

Gabriel was advised of his rights. Gabriel told us he understood his rights and he would speak to us, Gabriel signed a Miranda form telling us he wished to speak with us.

During this interview Gabriel disclosed he did know what was going on between Kevin, and Gabriel told us Kevin moved in with him around April of 2015 at the Crown Street address. Kevin also stayed with Gabriel on and off when he lived at his previous address.

Gabriel told us the last time something happened was on Thursday 09-10-15. Gabriel picked up and at Barbara's house. He brought them back to their house. He stayed with one child in the living room playing video games while Kevin took the other child into the room. They would stay in there for a while and then they would come out. Kevin would take the other child into the room while Gabriel stayed in the living room with the other child playing games. Once Kevin was done they took the children to Sports Authority where Kevin purchased some clothing for them. They went to Wendy's where they bought food and went to Cherry Hill where they ate the food. They took and home.

I asked what he thought Kevin was doing in the room. Gabriel told me he had an idea but he did not want to think Kevin would do something like that because he trusted Kevin. I told Gabriel he was aware of two other incidents Kevin had been in trouble for the same thing and I asked if he thought it was odd Kevin was taking the children into the room alone. Gabriel said he trusted Kevin and he did not think he would do something like that. Detective Harris asked Gabriel if he thought something was going on. Gabriel said, "I do." Harris told Gabriel that this was not the first time this has happened. Gabriel said, "No it isn't."

At one point I asked Gabriel if he had his phone on him. He said yes. I asked if he would get his phone on the table which he did. I asked if could look through his phone. He said yes. As I looked through the phone I found many photos of and in various forms of undress. Most of the photos were of them with their shirts off posing in various position. In one photo of had no shirt on and his pants were pulled down just above his groin area. I asked about the photos. Gabriel first told me Kevin took the photos and sent some to him. Gabriel later told me he took most of the photos and sent them to Kevin. I asked why. Gabriel told me Kevin asked him to send the photos. I asked why he sent them and what he was thinking. Gabriel told me he just thought Kevin wanted to see how the children were progressing in their growing stages.

Gabriel finally told us he has not been being very honest and he wanted to tell us the full truth.

Gabriel told us this has been going on since February. Gabriel would go get the two children and bring them home. They would go through the same scenario. Gabriel would keep one child in the living room while Kevin took the other in the room. Once Kevin was finished he would send the child out and take the other child into the room while Gabriel stayed in the living room playing games. Gabriel told us this has happened many times. When asked Gabriel told us he knew Kevin was taking pictures of them. He thought they were just photos with their clothes on but he knew there were others. Kevin told him was getting

more muscles. Gabriel told us he assumed Kevin was touching them. I asked why he would allow this to happen. Gabriel told us he did not want to believe it was happening. I explained that typically for someone to allow this to happen means they were abused at a younger age. I asked Gabriel if he was abused. Gabriel said yes. When he was years old by Kevin's brother, Paul. Gabriel did not want to go into details but said it was very sexual.

Gabriel told us at one point he was in the living room with when he walked into Kevin's room. He saw sitting on one bed naked and Kevin was sitting on the other bed across from . Kevin was fully clothed. Gabriel did not say anything he just closed the door and left the room. This incident happened in February or Early March at his previous address located at the Fair View Apartments #240 in CD'A.

Gabriel told us Kevin would pay him to go pick up the two children and bring them home so he could have his time with them. Kevin would pay Gabriel various amounts such as \$150.00 or Kevin would help pay for things. Kevin would also blackmail Gabriel by telling him he would move out and Gabriel would have to pay for everything on his own. Kevin would sometimes pay Gabriel the money after they dropped them off and other times Kevin would pay him later or not pay him at all.

Gabriel told us he knew what was happening between the two children and Kevin as far as the children being sexually abused. Kevin never directly told him what he was doing but Gabriel knew what was going on. On Thursday 09-10-15 after they dropped the children off Gabriel and Kevin went to Denny's. Kevin held his finger up in a crooked position and told Gabriel that is what penis looked like and that is how long it was. Gabriel told us he did not respond to Kevin he just kept eating his meal. Kevin also told Gabriel, was well hung and he was the most well hung out of anyone in their house.

Gabriel also told us the only nude photo Kevin showed him was of Kevin was holding penis straight out with his finger under penis. Gabriel even held up an ink pen and showed us how Kevin was holding the penis. I told Gabriel I did not believe him. I asked how many times Kevin showed him nude photos of the two children. I asked if it was five times; Gabriel said it was more than five.

At the end of the interview I asked Gabriel why he would allow this to happen. Gabriel told me Kevin was doing good things for them. Kevin was buying them things and being good to them.

This report is not in chronological order and it condensed for ease of the reader. Please see full recording for more details.

I recorded my interview on a digital recorder. It was loaded into Viper.

I was called into the PD by Sgt McCormick to help with a Lewd and Lascivious investigation. Sgt McCormick told me briefly talked with me about the details of the case and asked that I come to the PD and work on applying for an arrest warrant for Kevin Sloniker. I am familiar with Sloniker as he is a suspect from a previous Lewd and Lascivious investigation.

I responded to the PD and read the reports by Det Buhl and Det Harris. After reading their reports, I believed there was enough probable cause to be able to obtain an arrest warrant for Sloniker. I also contacted the on call representative for Transport Designs Inc. I was informed Sloniker would likely be in the Menomonie WI this evening or early tomorrow morning (09/14/2015).

I later appeared before the Honorable Judge Combo in application for an arrest warrant for Sloniker. Judge Combo found probable cause for the arrest warrant for two counts of Lewd and Lascivious conduct and signed the same. After obtaining the arrest warrant, I drove to the PSB and left the original arrest warrant at the PSB, taking a copy of the warrant with me. I then drove to the PD and contacted the Menomonie Police Department and spoke with Ofc Jake Brun. I talked with Ofc Brun about the warrant and some of the particulars of the case. Ofc Brun told me he would attempt to locate and arrest Sloniker and he would contact me later in the night if Sloniker was located.

I later spoke with Ofc Brun who advised Sloniker had been located and arrested. Ofc Brun also indicated he was able to seize Sloniker's cell phone, some data CD's, and a disposable camera.

09/22/15: I was given GABRIEL's phone to forensically review. I was also given a consent form from GABRIEL to perform this search. I put the phone into developer mode and debugged it. I then attached it to the computer and used oxygen forensic to make a copy of the phone. Upon completion of the phone I gave it back to Det. EUHL. I went through the phone's images and located numerous photos which appeared to be underage women based on facial features and breast development. I was able to find a phone number for one of the photos and I had Det. BUNL contact her. We found out she is 17 years old and she sent the photos when she was 16 almost 17 years old. I have not been able to determine who the girls are in the other photos.

I called and spoke with Commander Todd W Swartz with the Menomonie Police Department and requested to have the items seized at the time of Kevin Sloniker's arrest sent to the Coeur d'Alene Police Department. Commander Swartz told me he would ensure the seized items were sent overnight and I should expect them tomorrow, September 24, 2015.

The seized items are as follows:

1. One (1) Verizon Motorola Droid cell phone.
2. Three (3) Sony CD-R 700 mb data cds.
3. One (1) Walgreen's single use disposable camera.

Today I received a package sent overnight via UPS with tracking

Inside the package were four items sealed in brown paper bags. The bags were sealed with evidence tape and didn't appear to be tampered with. I opened all four bags and located the evidence items sent by Menomonie Police Department.

All items were booked into evidence at the Police Department.

I appeared before the Honorable Judge Morano and presented two affidavits and a search warrant. After reading through the report, Judge Morano found probable cause for the search warrant for the items seized by the Menomonie Police Department, which were now in the possession of the Coeur d'Alene Police Department. He also found probable cause for the search of Gabriel's phone.
