Christine Settanni called Crime Check on 01/12/15 to report that sometime between October 2005 and October 2006 her son was forcibly fondled and raped by Kevin Sloniker. Kevin was a family friend at the time. Christine's son, OCCOMO VICIMO O SEXUAL ASSAULT WAS ON A road trip to California with Kevin when he forcefully gave oral sex. This incident occurred in Los Gatos, California.

<u>In Post Fa</u>lls, Idaho during the same time frame Kevin rubbed become private parts with lotion. Then again in Latah, Washington during the same time frame.

now lives in Kansas with his mother Christine and felt comfortable enough being that distance away to tell Christine about the rape and molestation. There are no known witnesses at this time, however, Christine suspects that Kevin was also a victim of a sex crime as Kevin's sister confessed to Christine that she was also molested by their older brother. Kevin's sister did not want to provide her information at this time.

Christine has contacted her local law enforcement who advised her to call Crime Check for the report. The local law enforcement agency is willing to interview if needed for the investigation.

ADDITIONAL PERSONS AT END OF REPORT

June 29, 2015

0946hrs I received a voice mail from Kevin Sloniker who said he was available today for an interview, otherwise would not likely be available until late July.

1120hrs I returned Kevin's message and confirmed a 3:30pm interview with him at the Public Safety Building.

1520hrs Kevin arrived early for our scheduled meeting. I reminded Kevin the interview was being audibly and visually recorded which I'd explained in a previous phone call. I pressed the record button on my digital audio recorder but did not verify it actually started recording. I realized at the conclusion of the interview, there was not a separate audio recording of the interview, likely due to my not verifying the actual recording at the time.

During the interview with Kevin, he described his relationship with the Settanni family as somewhat close. Kevin said he spent a fair amount of time with the Settannis despite father, Paul being verbally abusive and his 4 siblings which made Kevin uncomfortable. Kevin told me Paul was suffering from cancer and eventually died as a result of the cancer. When Paul died, Kevin stopped visiting with the family out of fear of the impression it might give others. Kevin suggested his being a young single male would be looked at awkwardly with a now widowed woman. I offered Mrs. Settanni was more than twice his age, in her late thirties to early forties, but this did not change Kevin's impression of what others would think of his being around the family.

When asked about wisiting the Sloniker home, Kevin said he could only think of one or two times when this may have occurred but neither would have been a sleep over event. Kevin did say he was much more of a frequent visitor to the Settanni home than they to his.
Kevin also confirmed he went along with the Settannis to a church retreat in Los Gatos, CA. The group included his father Paul and wo younger brothers. Kevin said this was a boys only trip and his role was for driving support for Paul Settanni who was pretty well out of it due to his advanced cancer. Kevin said the trip was probably a 6-day trip. Kevin guessed he was about 19 years old at the time of the trip.
When asked about sexual contact between himself and Kevin repeatedly denied any such contact at his home in Latah, the Settanni home in Post Falls and in Los Gatos.
I asked Kevin about specific allegations made by penis? Kevin said, "Heck noI don't even remember him spending the night to be completely honest. There's no way in heck I would do that anyways. It's gress, that is disgusting."
When at house in Post Falls, did you tell his penis smelled and it needed to be cleaned? Kevin said, "No. And if something like that would have happened, I would have told him to clean it, but not have done itI generally would not tell a kid that I'd rely on his mom finding out for him. Or at least I hope she would."
Kevin said about and their relationship at that time, "As far as I remember, he was just one of the kids, like that's that's it. I never ever singled him out to spend time with or anything like that everI enjoyed the whole family getting out which I really needed because my parents needed to get out and enjoy themselves. So if we were to go to a hike as a family or go to church as a family, things like that, I would have never singled him out ever."
I asked Kevin if he'd ever had the opportunity to see genitals. Kevin said, "I don't want to answer that, but I will." Kevin went on to describe a room on the Settanni house with a glass door/slider visible to anyone in the living room or kitchen where if someone was inside and you'd not been forewarned, would be able to see anyone changing in the room.
Kevin also described an incident on the Los Gatos trip where Mr. Settanni forced his boys to rinse off nude at a public shower visible to everyone on the beach. Kevin described this incident as "Horrible." Kevin said Mr. Settanni did things like this to his children often and he'd seen Mr. Settanni getting angry with his kids quite frequently.

When asked how the results of a polygraph would reflect on our interview, Kevin said, "I don't know. I've never taken one." I asked if the polygraph was measuring truthful vs nontruthful responses, how would it indicate? Kevin said, "I would say I would pass. But I will have to say this, I don't know how they work. Cause there's a lot of trauma I have just thinking about that particular family. And you know very well, due to what I've told you, I've seen some things I'd rather not see."

I asked Kevin if he'd be willing to take a polygraph. Kevin asked for further explanation and vacillated between whether he would or would not take the polygraph. Kevin explained he had many friends, to include former police officers, who don't trust polygraphs and he would require time to think about the option.

Kevin explained he doesn't understand the allegations against him saying, "I still don't know where he's coming from...It makes no sense, I don't understand the lotion, I don't understand the Q-tip, I don't understand the whole pants, I don't understand the privates, I don't understand coming over to spend the night, I never remember him spending the night. I know his family came over during the day and left. Good riddance cause a peaceful farm was rather noisy."

I asked Kevin for his insight into a motive for to make false allegations against him. Kevin said, "I don't know. I can't think of anything. I was only nice to him and his family as I can remember. I wasn't the guy who showed up and wrecked his life. I wasn't the guy who disappeared and took something with me. It was a matter of hi, how are you and goodbye."
I asked Kevin if there had ever been any falling out between he and after Paul died. Kevin said, no, just that he didn't go around the family any longer due to the mom being single.
I ended the interview with the understanding from Kevin, he would contact me with an answer concerning his willingness to take the polygraph or not.
June 30, 2015
1227hrs I called and left a voice mail asking for a call back to give him an update on the case.
July 6, 2015
1503hrs I received call back from and updated him on the interview with Kevin. We discussed the possibility of his case reaching prosecution. Of particular importance was his decision to report this incident to police. This he said was because he'd lived with the secret for too long and a random encounter with Kevin in November of 2014 brought all of his experiences back to his mind. Thereafter, decided to finally report the incidents. Doing this has provided him with some closure.
confirmed he'd moved to Kansas with his mother in September of 2008. Since moving to Kansas, has not had any contact with Kevin until the random run-in at restaurant. The address of this is side of the restaurant accompanied by Kevin's sister,
confirmed the only other person he'd disclosed this information to was his aunt Theresa Linn approximately 3-4 years ago. Said when he told his aunt about the abuse, he requested she not share the information with anyone.
and I discussed what he remembered about some type of glass door of a bedroom on his old house in Post Falls as reported by Kevin. Said there was a glass rear slider door which was technically more like a back door to the home. There was a dresser located next to this door, but certainly there was not a bedroom with a glass door allowing a view into a bedroom where someone could be seen changing.

1050hrs Not having heard from Kevin Sloniker yet about the polygraph issue, I sent him an email asking if he'd made a decision.
1308hrs I called Theresa Linn and recorded my conversation with her. Theresa confirmed had disclosed to her some sexual abuse from his past. Theresa did not recall a name of the suspect or where it may have happened, but understood it to have happened in a place of privacy, possibly somewhere in Idaho during the time lived in Idaho. Theresa told me the disclosure was out of the blue and happened as she and were simply walking down his driveway. Theresa said body language obviously suggested his discomfort with discussing the ordeal with her as he stammered and was obviously nervous. Theresa told me she honored request of not disclosing anything about the event. Theresa did discuss the topic of sexual abuse with her sister, Christine but did not name as having been victimized.
Later Theresa spoke with Christine after had the encounter with Kevin at the Subway restaurant and confirmed had disclosed the information to her.
1340hrs I received a reply from Kevin via email stating he'd not given the polygraph any further consideration. I replied asking him to give it consideration as it was his opportunity to eliminate himself as a suspect. Kevin replied asking if a response by the following Monday or Tuesday would be acceptable. I replied telling him yes.
1510hrs I called Christine Settanni We discussed the time period of her sister Theresa's visit. Christine was unable to provide accurate information from memory. She offered she would check with her mother who handled all of the travel arrangements at the time and get back to me. She confirmed Theresa had actually spent several months with her family at that time.
Christine asked me about Kevin's sister and if I had spoken with her. I told her no. According to Christine, has told her Kevin's sister has shared information of being sexually abused by her older brothers but not Kevin. Apparently this sister is willing to provide information about her experiences which might explain why things could have happened to

On June 4, 2015 at approximately 1600 hours I met with Shawnee County Sheriff's Office, as we had previously arranged over the phone for him to come in and speak with me. I sat down to speak with and told him that I had first learned about the allegations of sexual abuse from a Detective in the Washington State area, as they had reached out to us, since was living in Shawnee County Sheriff's Office jurisdiction. They requested our support in talking to him and gathering information. I showed a document which was a short Narrative that I had been provided by the Detective in Washington State reference the original report made to them via phone by mother, Christine Settanni.

The January 13, 2015 document gave a very brief overview of the allegations. I showed it to and he read through it, and he said yes – that was the general overview of the allegations. I told as I did not have any further information other than what was provided in that document, that if he just wanted to start talking to me, where he felt that it would be best to start, and I could fill in with questions as we went along.

- 1. He said that he would start with the first event that had occurred, as that original document stated there were three incidents.
- 2. stated that each of the separate incidents occurred in separate states.
- 3. As I was unfamiliar with the area, he described to me that during that time frame, sometime between October 2005 and October 2006 was the time that he was living in Post Falls, Idaho, which is a community described as being right on the border of Idaho/Washington State.
- 4. He stated the suspect, named as "Kevin Sloniker" lived in Latah, Washington adjacent to Post Falls.
- 5. He said that a 3rd event took place in Los Gatos, California.
- 6. continued on to give some background information that he knew Kevin as a friend of the family, as Kevin's family and his family were friends, and attended the same church Immaculate Conception Church in Post Falls, Idaho.

- 7. He said that Kevin's family and his family had spent time together on several different occasions outside of church.
- 8. He said that several times his family had gone and spent time at Kevin's family's house in Latah, where all of the family members would be together.
- 9. He remembered playing on a trampoline in one of the many outbuildings or barns on Kevin's family's property, as he described it as being a very rural setting.
- 10. said he would first talk about the incident that he believes took place first.
- 11. It occurred at Kevin's parents' home in Latah during a "sleepover", while was staying the night with Kevin's family at their home.
- 12. He said that he could not remember how the sleepover came to be set up at that time cousin, was living with and his family, and was more of a close friend with Kevin than he was, because there was a large age gap between himself and Kevin.
- 13. At that time would have been approximately 8 years old, and Kevin was described as being of driving age.
- 14. was uncertain if his parents had dropped him off on that particular day at Kevin's house, or if Kevin would have come to his house to pick him up and taken him to his house.
- 15. He believed he arrived in the afternoon at Kevin's family's home and that while getting ready for bed that night, it was set up for him to stay in Kevin's bedroom, which was on the second floor.
- 16. Kevin's family was described as his mother and father living in the home, and at that particular time Kevin's older brother Paul was also living in the home.
- 17. The family was described as having many other children, but they were older and had moved out of the house.
- 18. believes Kevin's mom and dad would have been downstairs, unknown if awake or asleep when the incident occurred.
- 19. and Kevin were in Kevin's bedroom getting ready for bed.
- 20. was wearing his pajamas, and Kevin made a comment about penis smelling
- 21. Kevin said that he would get some lotion to "get rid of the smell".
- 22. Kevin then exited the bedroom, went across the hall to his brother Paul's room and overheard Kevin ask Paul where the lotion was, but did not recall or hear any of the other short conversation.
- 23. Kevin came back into the room with some lotion and began rubbing it on penis.
- 24. could not recall if his pants had been pulled down, or if Kevin was simply reaching into his pants.

25. said that after Kevin rubbed his penis with the lotion for a period of time, he stopped and then had touch Kevin's penis.

I asked if it was erect.

26. He said he believed it was.

I asked if Kevin had him rub on his penis.

27. He said, "Just touching it".

I asked if either one of them ejaculated.

28. He said no.

I asked if he became aroused during the rubbing of the lotion on his penis.

- 29. He said he couldn't recall.
- 30. said that during this time of the touching of the penises that Kevin was talking to him about the difference between boys and girls parts and how boys' penises go into girls vaginas.
- 31. He said that after this incident ended the two went to bed in the bedroom and there was no more talk of the incident and no more talk the next day.
- 32. He believed left and went home sometime the next morning.
- 33. said he only stayed there that one night.
- 34. He believed the time of year would have been spring or winter, but was not sure if it was a weekend or during school.
- 35. said that he attended the Immaculate Conception Academy, which was the private school associated with their family's church.

I asked about his family and siblings.

- 36. He said during the time of the incidents he was living with both his mom and dad, and a couple of siblings.
- 37. He said he could not recall the exact timeline, and which siblings would have been born, but currently his siblings that he has, going from oldest to youngest:

- 38. said that the next two occurrences he was unsure as to which occurred next.
- 39. He believed the next to have occurred at his own family's home in Post Falls.
- 40. That address, he believed, was 30 Ch d volmo se usl see lin Post Falls.
- 41. He described the next incident occurring in his own bedroom on the second floor.
- 42. No one else was present.
- 43. He said it was daytime, possibly after school hours in the afternoon.
- 44. He said Kevin came over to his family's house.
- 45. He said Kevin drove himself.
- 46. He believed that at home at the time was his mother, brother and possibly brother
- 47. He said that when the two were upstairs in his bedroom that Kevin brought up the topic and was acting "somewhat like a doctor", as he was "checking" on penis.
- 48. remembers his pants being pulled down.
- 49. He did not recall if Kevin told him to pull his pants down or if Kevin did it himself.
- 50. Temperature remembers being very embarrassed when his pants were down, so he told Kevin to close the door, which Kevin did.
- 51. Kevin began rubbing penis approximately a minute or two.


I asked if he or Kevin had an erection during this time.

I asked about the frequency of Kevin coming by their family's home.



- 54. said he would typically come by once or twice a month, and it was mainly in a group setting with family around.
- 55. said that from what he recalled, he believed that the frequency of Kevin coming around was higher after the first sexual incident.

The third incident was described as during a trip to Los Gatos, California – believed to be a "Spring Break" trip. Those that went on the trip were dad, , , brothers , and brothers , and believed that Kevin came along as an extra driver, as at that time dad had been

He believed he was in the 2nd or 3rd Grade, roughly, for that trip. then stated that was the last incident – that a period of time after that, had a girlfriend of hers tell her that her son had been inappropriately touched by Kevin and brought it to mom's attention. mom asked him if Kevin had done anything inappropriate with him, and Kevin said that he was embarrassed and uneasy about it, and told her no. mother told Kevin that he could not be around any of the kids, 79. But after that time, unsupervised. said that he, in the past, had told one of his aunts about the sexual encounters with Kevin, as he was having a hard time living with the secret. 81. He said he told his Aunt in approximately 2011 or 2012, but he begged for her not to - tell-anyone as he was so embarrassed. He told her because he felt overwhelmed by the secret and needed to tell someone.

- 82. went on to say that January 2015 is when he first told his mother.
- 83. He said that after that time, mother, Christine, contacted that old friend where they had previously lived, and inquired, and then contacted that son who had also been abused by Kevin, indicated that had come forward as also being abused.
- 84. They said they were contacting Law Enforcement and inquired if the other individual would also want to, and he stated that he did not wish to do so and wanted to remain anonymous.
- 85. l asked if I was aware of other criminal or incidents involving him.

86. He said that when he was younger – approximately 2 to 3 years old – his dad had been investigated/arrested for abusing him, as had been told that he had a hand-mark and bruises on the face and buttocks due to slapping and spanking.

I asked about the outcome of that.

87. He said that he believed his dad had to undergo some form of "anger-management" training, but had remained in the home; however was removed from the home for approximately two to three weeks right around when the incident was reported.

When talking about reporting these incidents to his Aunt earlier, I asked if he had told anyone else.

- 88. again began breaking down and with eyes watering up he said that no, he had not.
- 89. He said that he had not told his parents especially his dad, as he was fearful of being blamed for it and physically punished, as he "did not grow up in the best home", as his dad was not the nicest.
- 90. He said that his dad had died of cancer and that is when they moved back to Kansas.
- 91. He believed that his dad passed in '06 or '08 he was uncertain.
- 92. told me that he had been home-schooled, and recently got his G.E.D.
- 93. He had been working at in St. Mary's for a period of time and when he turned 18 recently he became Asst. Manager.
- 94. He told me I could contact his mom if need be at cell

I asked if he had spoken to any Counselors or anything in reference to this abuse.

- 95. He said no. -

I encouraged him to do that if he thought that might be helpful at all. I gave my business card with all of my contact information and encouraged him to contact me if I could be of any assistance to him. I told him that I would complete the information he had given to me, compile it into a report and forward it on to the originating agency in Washington State. I then escorted out of the LEC.

I then called his mother, Christine M. Settanni (WF,). I introduced myself, said I had just got done speaking with and stated that had brought up that there should be pictures of the trip to California and that those pictures might possibly have date stamps on them, to get a closer timeframe for these incidents. She said she would go home late that evening, go through them and

contact me back. I encouraged her to contact me if she had any further questions. She said she believed that she had most of her questions answered when she made the initial report, and subsequently had been talking with Law Enforcement in Washington State. I have nothing further at this time.



0946hrs I received a voice mail from Kevin Sloniker who said he was available today for an interview, otherwise would not likely be available until late July.

1120hrs I returned Kevin's message and confirmed a 3:30pm interview with him at the Public Safety Building.

1520hrs Kevin arrived early for our scheduled meeting. I reminded Kevin the interview was being audibly and visually recorded which I'd explained in a previous phone call. I pressed the record button on my digital audio recorder but did not verify it actually started recording. I realized at the conclusion of the interview, there was not a separate audio recording of the interview, likely due to my not verifying the actual recording at the time.

During the interview with Kevin, he described his relationship with the Settanni family as somewhat close. Kevin said he spent a fair amount of time with the Settannis despite father, Paul being verbally abusive and his 4 siblings which made Kevin uncomfortable. Kevin told me Paul was suffering from cancer and eventually died as a result of the cancer. When Paul died, Kevin stopped visiting with the family out of fear of the impression it might give others. Kevin suggested his being a young single male would be looked at awkwardly with a now widowed woman. I offered Mrs. Settanni was more than twice his age, in her late thirties to early forties, but this did not change Kevin's impression of what others would think of his being around the family.

When asked about visiting the Sloniker home, Kevin said he could only think of one or two times when this may have occurred but neither would have been a sleep over event. Kevin did say he was much more of a frequent visitor to the Settanni home than they to his.

Kevin also confirmed he went along with the Settannis to a church retreat in Los Gatos, CA. The group included his father Paul and boys only trip and his role was for driving support for Paul Settanni who was pretty well out of it due to his advanced cancer. Kevin said the trip was probably a 6-day trip. Kevin guessed he was about 19 years old at the time of the trip.

When asked about sexual contact between himself and Kevin repeatedly denied any such contact at his home in Latah, the Settanni home in Post Falls and in Los Gatos.

At your home in Latah, Did you rub lotion on penis? Kevin said, "Heck no...I don't even remember him spending the night to be completely honest. There's no way in heck I would do that anyways. It's gross, that is disgusting."

When at house in Post Falls, did you tell his penis smelled and it needed to be cleaned? Kevin said, "No. And if something like that would have happened, I would have told him to clean it, but not have done it...I generally would not tell a kid that I'd rely on his mom finding out for him. Or at least I hope she would."

Kevin said about and their relationship at that time, "As far as I remember, he was just one of the kids, like that's that's it. I never ever singled him out to spend time with or anything like that ever...I enjoyed the whole family getting out which I really needed because my parents needed to get out and enjoy themselves. So if we were to go to a hike as a family or go to church as a family, things like that, I would have never singled him out ever."

I asked Kevin if he'd ever had the opportunity to see general genitals. Kevin said, "I don't want to answer that, but I will." Kevin went on to describe a room on the Settanni house with a glass door/slider visible to anyone in the living room or kitchen where if someone was inside and you'd not been forewarned, would be able to see anyone changing in the room.

Kevin also described an incident on the Los Gatos trip where Mr. Settanni forced his boys to rinse off nude at a public shower visible to everyone on the beach. Kevin described this incident as "Horrible." Kevin said Mr. Settanni did things like this to his children often and he'd seen Mr. Settanni getting angry with his kids quite frequently.

When asked how the results of a polygraph would reflect on our interview, Kevin said, "I don't know. I've never taken one." I asked if the polygraph was measuring truthful vs nontruthful responses, how would it indicate? Kevin said, "I would say I would pass. But I will have to say this, I don't know how they work. Cause there's a lot of trauma I have just thinking about that particular family. And you know very well, due to what I've told you, I've seen some things I'd rather not see."

I asked Kevin if he'd be willing to take a polygraph. Kevin asked for further explanation and vacillated between whether he would or would not take the polygraph. Kevin explained he had many friends, to include former police officers, who don't trust polygraphs and he would require time to think about the option.

Kevin explained he doesn't understand the allegations against him saying, "I still don't know where he's coming from...It makes no sense, I don't understand the lotion, I don't understand the Q-tip, I don't understand the whole pants, I don't understand the privates, I don't understand coming over to spend the night, I never remember him spending the night. I know his family came over during the day and left. Good riddance cause a peaceful farm was rather noisy."

I asked Kevin for his insight into a motive for said, "I don't know. I can't think of anything. I was only nice to him and his family as I can remember. I wasn't the guy who showed up and wrecked his life. I wasn't the guy who disappeared and took something with me. It was a matter of hi, how are you and goodbye."

I asked Kevin if there had ever been any falling out between he and after Paul died.

Kevin said, no, just that he didn't go around the family any longer due to the mom being single.


I ended the interview with the understanding from Kevin, he would contact me with an answer concerning his willingness to take the polygraph or not.

and I discussed what he remembered about some type of glass door of a bedroom on his old house in Post Falls as reported by Kevin. Said there was a glass rear slider door which was technically more like a back door to the home. There was a dresser located next to this door, but certainly there was not a bedroom with a glass door allowing a view into a bedroom where someone could be seen changing.

On June 4, 2015 at approximately 1600 hours I met with Shawnee County Sheriff's Office, as we had previously arranged over the phone for him to come in and speak with me. I sat down to speak with allegations of sexual abuse from a Detective in the Washington State area, as they had reached out to us, since was living in Shawnee County Sheriff's Office jurisdiction. They requested our support in talking to him and gathering information. I showed document which was a short Narrative that I had been provided by the Detective in Washington State reference the original report made to them via phone by mother, Christine Settanni.

The January 13, 2015 document gave a very brief overview of the allegations. I showed it to and he read through it, and he said yes – that was the general overview of the allegations. I told as I did not have any further information other than what was provided in that document, that if he just wanted to start talking to me, where he felt that it would be best to start, and I could fill in with questions as we went along.

- 1. He said that he would start with the first event that had occurred, as that original document stated there were three incidents.
- 2. stated that each of the separate incidents occurred in separate states.
- 3. As I was unfamiliar with the area, he described to me that during that time frame, sometime between October 2005 and October 2006 was the time that he was living in Post Falls, Idaho, which is a community described as being right on the border of Idaho/Washington State.
- 4. He stated the suspect, named as "Kevin Sloniker" lived in Latah, Washington adjacent to Post Falls.
- 5. He said that a $3^{\rm rd}$ event took place in Los Gatos, California.
- 6. continued on to give some background information that he knew Kevin as a friend of the family, as Kevin's family and his family were friends, and attended the same church Immaculate Conception Church in Post Falls, Idaho.

- 7. He said that Kevin's family and his family had spent time together on several different occasions outside of church.
- 8. He said that several times his family had gone and spent time at Kevin's family's house in Latah, where all of the family members would be together.
- 9. He remembered playing on a trampoline in one of the many outbuildings or barns on Kevin's family's property, as he described it as being a very rural setting.
- 10. Second victim of examples and he would first talk about the incident that he believes took place first.

- 19. and Kevin were in Kevin's bedroom getting ready for bed.
- 20. was wearing his pajamas, and Kevin made a comment about penis smelling.
- 21. Kevin said that he would get some lotion to "get rid of the smell".
- 22. Kevin then exited the bedroom, went across the hall to his brother Paul's room and overheard Kevin ask Paul where the lotion was, but did not recall or hear any of the other short conversation.
- 23. Kevin came back into the room with some lotion and began rubbing it on penis.
- 24. could not recall if his pants had been pulled down, or if Kevin was simply reaching into his pants.

- 42. No one else was present.
- 43. He said it was daytime, possibly after school hours in the afternoon.
- 44. He said Kevin came over to his family's house.

- 46. He believed that at home at the time was his mother, brother and possibly brother
- 47. He said that when the two were upstairs in his bedroom that Kevin brought up the topic and was acting "somewhat like a doctor", as he was "checking" on penis.

I asked why none of other family (mom and sisters came).

I asked if any others from their church would have gone down with the group.

1335hrs I left a voice message and sent an email for Sgt. Andrew Dale with the Shawnee County Sheriff's Office in Topeka, Kansas requesting assistance in interviewing

May 20, 2015

I received an email back from Sgt. Dale who notified me Det. Roberts would be assigned to assist me with the interview.

May 21, 2015

I received an email from Det. Roberts notifying me of his intent to meet with the following week and get back to me.

June 12, 2015

I received an email from Det. Roberts which included his report detailing his interview of Reviewing the report, I noted reported being sexually molested by Kevin in three different locations. One being at home in Post Falls Idaho, at Kevin's home in Latah, WA and the third in Los Gatos, California on a church function.

I contacted Special Agent Jason Benedetti of the Spokane FBI office and asked if the FBI would consider investigating this case due to the multi-state crime locations. Agent Benedetti told me he doubted the FBI would act as a primary investigative agency. He contacted his supervisor for final determination.

June 15, 2015

Special Agent Benedetti confirmed the FBI would not take a lead investigative role in this matter but offered any assistance needed.

June 16, 2015

I contacted Dep. Mike McNees and asked if he would go to the Latah address which appears to be the most recent and only verifiable contact information for Kevin Sloniker. There he met with Frederick Sloniker who identified himself as Kevin's father. Frederick told Dep. McNees he does not know where Kevin lives or works. Frederick offered Kevin works for an unknown trucking company possibly out of Michigan. Frederick eventually gave Dep. McNees Kevin's cell phone number of 208-818-0521. Dep. McNees also left Frederick with my phone number to pass on to Kevin.

1459hrs I received a voice mail from and the male caller identified himself as Kevin Sloniker and explained he'd been told to call me.

June 18, 2015

1115hrs I called Kevin Sloniker at Kevin asked why he was being contacted. I told him it was in regard to allegations made by concerning sexual contact about 10 years ago. Kevin denied doing anything to saying, "That doesn't make sense. I only knew the family" Kevin then asked, "Is there anything you can do this late?"

I explained to Kevin I simply had an allegation at this point and was hoping to get his statement and pursue the truth. I explained an interview with me would be video and audio recorded to accurately document any questions and answers.

- She made an initial police report on behalf of to the Spokane County Sheriff's Office concerning allegations of being sexually touched by Kevin G Sloniker approximately 10 years earlier.
- Her best estimate for the period of time for her sister Theresa Settanni's visit to her home and when would have disclosed to her would have been sometime around 2010 or 2011.

Witness Sloniker can testify to the following:

- She was with her brother Kevin Sloniker in November 2014 when they went to a where oscillated a sall worked.

Christine also provided contact information for Sloniker who was currently in a rehabilitation facility with limited phone contact.
